## General Rules of Participation:

- Must be 60 years of age or older
- Must be a Union County resident
- Must not be a Farmers' Market vendor
- Gross income level must be \$1,670/month or less for a single person, or \$2,245/month or less for a household of two
- An application provided by Union County Senior Services must be filled out, signed by the senior and returned to Union County Senior Services along with proof of income from all sources i.e. Social Security Statement or awards letter, pension statement, bank statement
- Eligible seniors may designate one proxy on their application (to pick up produce if unable to make it to the market themselves)
- Coupons will be distributed by Union County Senior Services on a monthly basis (\$20/ single; \$30/couple each for July, August and September)
- Please use coupons within the month marked
- Coupons may only be used for fresh fruits and vegetables, honey and homemade jams and jellies (baked goods, soaps and fresh flowers do not qualify)
- Coupons may be redeemed only at participating roadside stands and farmers' markets in Union County displaying our logo (a list will be provided with your coupons)
- Coupons must be signed by the participant prior to being redeemed
- No change will be given from the coupons used. Use the full amount (\$2 per coupon)
- Coupons will not be reissued if lost or misplaced or address provided is incorrect or has changed
- Coupons are non-transferable but may be redeemed for the senior by a designated proxy
- Completion of application does not ensure enrollment in the Healthy Seniors Farmers' Market Program
